

**REQUIRED APPLICATION DOCUMENTS
FOR INTERNATIONAL F-1 VISA STUDENTS
ACADEMIC YEAR 2021-2022**

Thank you for your interest in attending Northampton Community College. Any student who is or intends to be in the United States with an F-1 student visa is considered an international student. In order for us to prepare your SEVIS Form I-20, which is required when you apply for your student visa, you must submit the following application documents:

1. Submit your application

- a. Apply online at <https://www.northampton.edu/international-apply.htm>.
- b. Fall semester applications should be received by July 15. Spring semester applications by November 15.

2. Submit proof of financial support

You must prove that you have at least \$28,890.00 readily available for educational expenses. Acceptable sources of funding include checking or saving accounts, money market accounts, and certificates of deposit.

- a. Complete and submit the enclosed Certification of Finance form.
- b. Submit bank letters and/or statements to verify funds indicated on Certification of Finance.
